 with effect from academic session 1996-97 (without aid).

Sir,

With reference to your application on the subject cited above I am directed to convey the approval of the Director of Education for the recognition of the school upto Secondary Level without aid w.e.f. 1996-97 academic session subject to the following terms and conditions:-

- 1) That the school shall admit students without any discrimination of caste and creed.
- 2) That a proper library hall be established and facilities for reading room also shall be made available for students as well as teachers. Books as per the ratio of books 10 books per student shall be purchased and made available to the students.
- 3) That adequate sports materials shall be purchased and made available to the students.
- 4) That the school shall strictly abide by the provision of section 10(1) of DSER-1973.
- 5) That the school shall strictly not run any unauthorised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the premises of the school immediately.
- 6) That the school shall dispense with the service of unqualified and over-aged staff, if any immediately.
- 7) That the service contract between the management and the employees be revised as DSER-1973, shall be executed immediately.
- 8) The Management Committee shall regulate the functioning of school strictly in accordance with the provision of DSER & Rules, 1973.
- 9) Managing Committee of the school shall not increase fee in future academic session without prior approval of Director of Education which is mandatory requirement.

- 10) That all the facilities prescribed under rule-50 & 51 of the DSEA & Rules, 1973 shall be made available to the students.
- 11) That staff has been paid arrear and being paid as per Forth Pay Commission. Proof given to EO/DSO for verification.
- 12) That the arrangement for good drinking water shall be made available to all the students as well as the teachers and sanitary facilities shall also be provided to the students.
- 13) Medical facilities/leave, LTC, Bonus, teaching allowance, GPF etc. be paid since recognition of school.
- 14) Provident fund register be maintained and cash book be completed and shown to EO of the Zone concerned for verification from time to time.

- 15) That the violation of any instruction/condition/rules and regulation of the department shall lead to the withdrawal of recognition of the school.
- 16) That the science lab. have to be improved/renovated by the school.
- 17) That the management of the school shall create a reserve fund to the tune of three months salary to the staff of the school.
- 18) That the school shall restrict the enrolment in every class on the ratio of 10 sq.ft. per student.
- 19) That report about fulfilment of the above condition shall be sent to EO every six months.


